The Graduate School of Science and Technology (GSST) at Kumamoto University offers the opportunity to apply for the Japanese Government (Monbukagakusho) Scholarship for those who wish to enroll in the Doctoral Course of the International Joint Education Program for Science and Technology (IJEP). The main language used in this Program for classes and research is English. Basic Japanese language courses are offered at the College of Cross-Cultural and Multidisciplinary Studies.

## Research and Educational Fields

### Department of Science

**Course:** Mathematics, Physics, Chemistry, Earth and Environmental Sciences, Biological Sciences

### Department of Advanced Industrial Science

**Education program:** Environmental Conservation Engineering, Environmental Management and Planning, Architecture and Environment Planning, Building Materials and Structures, Advanced Mechanical Systems, Intelligent Mechanical Systems, Applied Mathematics, Computer Science and Communication Engineering, Frontier Technology for Energy and Devices, Human and Environmental Informatics, Applied Chemistry and Biochemistry, Materials Science and Engineering

## Qualifications of Applicants

- 1) Nationality: must have a nationality from a country that has diplomatic relations with Japan, and come to Japan from abroad as a student.
- 2) Age: must have been born on or after April 2, 1984.
- 3) Education:

Applicants must fulfill one of the following conditions from ① to ③

When one's application is based on ② or ③, qualification will be subjected to prior screening. For application to prior screening, follow the guidelines on page 4.

- ① Hold a Master's degree or are expected to complete the degree by September 2019. Those who are graduating in September 2019 from a university in Japan are excluded.
- ② Conducted research for more than 2 years in a university or a research institute after completion of the 16 years of formal education outside of Japan and recognized to have an equivalent level of education to the Master's degree by GSST.
- ③ Are recognized by GSST to have attainments equal to or higher than Master's degree holders, and must be aged 24 years old or older as of September 30, 2019.

- 4) GPA: GPA of your grades in the last two years must be equal to or greater than 2.30 based on the calculation method below. Numbers must be rounded down to two decimal places.

After calculating the grade points, apply them to the following calculating formula.

[Calculating method]

$$\frac{(\text{Units of GP3} \times 3) + (\text{Units of GP2} \times 2) + (\text{Units of GP1} \times 1) + (\text{Units of GP0} \times 0)}{\text{All the registered units}}$$

Note:

1. If your grading system is not based on units, it can be replaced to the number of subjects.
  2. It should exclude any evaluation other than ones in the table above such as “qualification”, “Pass” etc.
  3. If you have been enrolled for less than two years in your current university, which grades its students’ scholastic performance every half year and the total number of your enrollment years at universities has a fraction which is less than one year because your previous university grades its students’ scholastic performance every year, your GPA should be calculated based on your grades in the last two and a half years.
- 5) Health: must be in good physical and mental health.
  - 6) Language: must have good English communication skills equivalent to or more than B2 level of CEFR (Common European Framework of Reference for Languages). The applicants should have an official score of either TOEFL, TOEIC, or IELTS. The minimum scores are 72 for TOEFL-iBT (543 for TOEFL-PBT), 785 for TOEIC, and 5.5 for IELTS.
  - 7) Time of arrival: must be able to arrive in Japan between September 25 and October 8, 2019. When it is not possible, the travel expense will not be paid.
  - 8) Visa: must have a student visa when coming to Japan.

**Note:**

1. Military personnel and military civilian employees are excluded.
2. The admission will be revoked if recipients fail to arrive in Japan during the designated period.
3. Those who received Monbukagakusho Scholarship in the past have to have at least 3 years of experience

in education and research before reapplying to the scholarship. However, those who returned to home countries and graduated from home universities after having finished the Program for Japanese Studies Students, the Japan-Korea Joint Exchange Program for Students in Science and Engineering, or the Young Leaders' Program are not subjected to this rule.

4. Recipients of fellowships/scholarships from any other sources are not eligible.
5. Those who are currently enrolled in a Japanese university with a student visa (ryugaku) or going to become a private-funded student of a university in Japan in 2019 are not eligible. However, those who will go back to their home countries after completion of study in Japan and return to a Japanese university are not subjected to this rule.
6. Those who are expecting to receive scholarships from institutions (including home government) other than the Japanese Government (MEXT) or JASSO after arrival in Japan are not eligible. (Those who have been funded by MEXT or JASSO and continue to be funded as a student from October 2019 are not eligible)
7. The admission will be revoked if recipients fail to fulfill the educational requirements as stated by September 2019.
8. Holders of dual nationality at the time of application who fail to demonstrate that they have given up Japanese nationality by the time of arrival in Japan are not eligible.
9. MEXT scholarship is for applicants who enroll in a Japanese university and conduct research activity in Japan. Therefore, those who wish to carry out fieldwork or internship abroad at the time of application are not eligible.

## **Prior Screening**

### **<Guidelines for prior screening for qualification for application>**

When your educational qualification is based on ② or ③ on page 2, prior screening is required. Contact the International Affairs Section ([gsst-aas@jimu.kumamoto-u.ac.jp](mailto:gsst-aas@jimu.kumamoto-u.ac.jp)) first and then submit the required documents via email during the submission period indicated below. If you pass the screening, submit the application documents on page 6 and 7 during the application period.

#### **(1) Required documents for prior screening**

- ① Application form for the screening of the qualification for application (obtained from International Affairs Section)
- ② Certificates of Bachelor's degree and Master's degree (or a certificate of anticipation of completion), or copies of diplomas (original and English translation).
- ③ Official transcripts of academic records in English from each college and university attended, including information such as GPA and ranking.
- ④ Summaries of Bachelor's thesis and Master's thesis or equivalents in English.

(4) Result of the screening

The result will be informed to the applicants after the screening.

**Duration of the Scholarship:** October 2019– September 2022 (3 years)

### Scholarship Benefits

- 1) Stipend: 145,000 yen per month (subject to change).
- 2) Travel expenses are covered by MEXT
  - Travel to Japan: An economy class airfare from a nearest international airport of a recipient's residence in his/her country to Narita International Airport or to Fukuoka International Airport will be provided. Airport tax and special taxes related to the trip will not be covered.
  - Travel to a recipient's home country from Japan: At the time of returning to a home country by the designated completion date of the scholarship, an economy class airfare from Narita International Airport or from Fukuoka International Airport to an international airport in his/her home country will be provided.

Note:

1. If a recipient returns home despite of having applied for extension of scholarship period, in principle, he/she will not receive travel expenses to return home.
2. Insurance premiums for travel to/from Japan shall be borne by the recipient.
3. If a recipient continues to stay in Japan after the scholarship period has ended, he/she will not receive travel expenses to return home temporarily.

- 3) Fees for examination, enrollment and tuition will be exempted.

**Date of Enrollment:** October 1, 2019

### Degrees

After successful fulfillment of the course requirements, Doctor of Science, Doctor of Engineering, or Doctor of Philosophy will be conferred.

### Application Procedure

#### Step 1

Check whether you fulfill the qualifications of applicants (See on page 2). When your educational qualification is based on ② or ③, prior screening must be conducted. For application to prior screening, follow the guidelines on

### **Step 2**

Contact a prospective supervisor in Kumamoto University and ask whether you can apply for MEXT scholarship under his/her supervision. It is highly recommended that applicants contact the prospective supervisor at least three weeks before application deadline.

### **Step 3**

After obtaining confirmation from the prospective supervisor in Step 2, please have interviews with the prospective supervisor and at least two more faculty members from the related field(s). When interviews in person are not possible, the applicants should have at least nine internet interview sessions by three faculty members (three sessions each). Interviews must be completed within one year of the application deadline. For more details about interview procedure, please contact your prospective supervisor.

### **Step 4**

Submit the following documents to the International Affairs Section via express postal mail by the application deadline.

## **Application deadline: February 13, 2019**

\*Please note that hard copies of all the documents must arrive at the office by the application deadline.

## **Required Documents**

- 1) Application form for IJEP in GSST.
- 2) Application form for Japanese Government (Monbukagakusho: MEXT) Scholarship.
- 3) Field of study and research plan.
- 4) Health certificate completed within the past 6 months of the date of application.
- 5) Statement of objectives describing reasons for application to the Graduate School, how the applicant qualifies to be a graduate student, and the applicant's academic, research, and professional goals.
- 6) A certificate of Bachelor's degree and a certificate of Master's degree (or a certificate of anticipation of completion), or a copy of a diploma (original and English translation. Photocopies need to be attested by an authorized person of the university).
- 7) Certified official transcripts in English of academic records from each college and university attended, including information such as GPA and ranking. The transcript should show the grade scale applied and the grades earned

by the applicant in all the subjects studied for each year of study at the college and/or the university.

- 8) Summaries of Bachelor's thesis and Master's thesis or equivalents in English.
- 9) A copy of the applicant's passport, or an official certificate of citizenship (original and English translation).
- 10) A letter of recommendation in English from the head of the faculty or graduate school, or someone at a higher position of the applicant's home university or institution. **The letter should be addressed to "President of Kumamoto University"**.
- 11) A letter of recommendation in English from a professor or a research supervisor who can evaluate the applicant's ability in study and research.
- 12) A letter in English from the employer indicating knowledge and consent of this application, if the applicant is an employee.
- 13) An official score of TOEFL, TOEIC, or IELTS, if the applicant's native language is not English. Although official scores are required, institutional scores such as TOEFL-ITP, TOEIC-IP, and TOEFL or IELTS equivalent test administered in universities may be accepted. Scores are valid only if dated within two years of the application deadline.
- 14) A letter from the applicant stating his/her commitment to the enrollment to Kumamoto University when selected for the scholarship.
- 15) Application Materials Checklist (format available on website)  
Please make sure that you have all documents by using the Application Checklist before sending the documents.

**Note:**

1. Applicants are advised to discuss research plans with their prospective supervisors beforehand.
2. All the documents should be typewritten on A4 size paper (21 x 29.5 cm).
3. Use the forms provided by Kumamoto University for the above documents 1) to 4).
4. Incomplete applications or applications submitted after the deadline will not be accepted.
5. Application materials will not be returned to the applicants.

## **Selection Procedure**

- 1) The GSST selection committee will examine the application materials and the result of the interview to select applicants to recommend to the university level selection (no limit to the number of recommendation). Applicants should have interviews by a prospective supervisor and at least two more faculty members from the related field(s). When interviews in person are not possible, the applicants should have at least nine internet

interview sessions by three faculty members (three sessions each). Interviews must be completed within one year of the application deadline.

- 2) The university level selection committee will select applicants. Selected applicants will be recommended to the Japanese Government (Monbukagakusho, MEXT) for further review and selection.
- 3) The result of the university level selection will be informed to the applicants in late March, and the final decision from MEXT will be informed in July.

## **Attention**

- 1) Scholarship may be repealed in the following cases.
  1. There are false statements in the application.
  2. Students fail to follow the pledge to Monbukagakusho.
  3. Students fail to follow any Japanese laws.
  4. Students are expelled or dismissed from the university as a disciplinary measure, or judged to be difficult to complete academic requirements.
  5. The status of student visa is changed to other types of visa.
  6. Students receive scholarship from sources (including their own government) other than Monbukagakusho.
  7. Students leave the university or transfer to another university.
- 2) When recipients are absent from school for an extended period, take a leave of absence, or stay outside of Japan for fieldwork, the payment of scholarship will be stopped.
- 3) Applicants are advised to become familiar with Japanese culture, customs, climate, and the university system before coming to Japan. Japanese language skills for daily life would be advantageous.
